BYLAW TO APPOINT A CHIEF BUILDING OFFICIAL, PROPERTY
STANDARD OFFICER FOR THE CORPORATION OF THE TOWN OF AMPRIOR
AMERICAN Section 3.15 (1) of the Building Code No. 6.0. 1982, a 22 metres
provisions that the owner of each residential structure shall employ a chief building official and
notwithstanding to any contrary to the provisions of the Act, in the areas in which
the municipality is provided.
AND WHEREAS Section 1.17 of the Building Code No. 6.0. 1982, is 23 metres for
the appointment of a Property Standards Officer for the purposes of administering and
enforcing the provisions of Section 3.15 of the Building Code No. 6.0.

AMPRIOR DO HEREBY ENACT:
1. That John MOORE (J.M.) be appointed the Chief Building Official/Property
Standards Officer for the CORPORATION OF THE TOWN OF AMPRIOR.
2. That the chief officer shall have such powers as the passing thereof.
3. That Bylaw No. 5978-11 be hereby repealed.

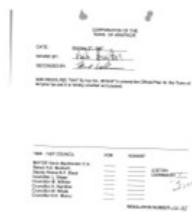
