THE CORPORATION OF THE TOWN OF ARNPRIOR
 BY-LAW 6146-12
 A BY-LAW OF THE TOWN OF ARNPRIOR (ENACTED BY COUNCIL) THAT REPEALS THE TOWN OF ARNPRIOR BY-LAW 6146-12, AS AMENDED, AND REPLACES IT WITH THE FOLLOWING:
 WHEREAS Section 203(1) of the Planning Act, R.S.O. 1990, as amended, provides that an order made by a Council of a municipality in respect of a plan which provides for zoning or other land planning that does not apply to such lands as designated in the Schedule;
 Now therefore the Council of the Corporation of the Town of Arnprior enacts as follows:
 1. Subject to Section 203(1) of the Planning Act, as amended, 2008, the following shall apply to the lands described in Schedule 1 of this By-law in the Town of Arnprior, County of Renfrew:
 2. This by-law shall be effective only to the extent necessary to permit:
